Maryland State Firemen's Association Legislative Brief

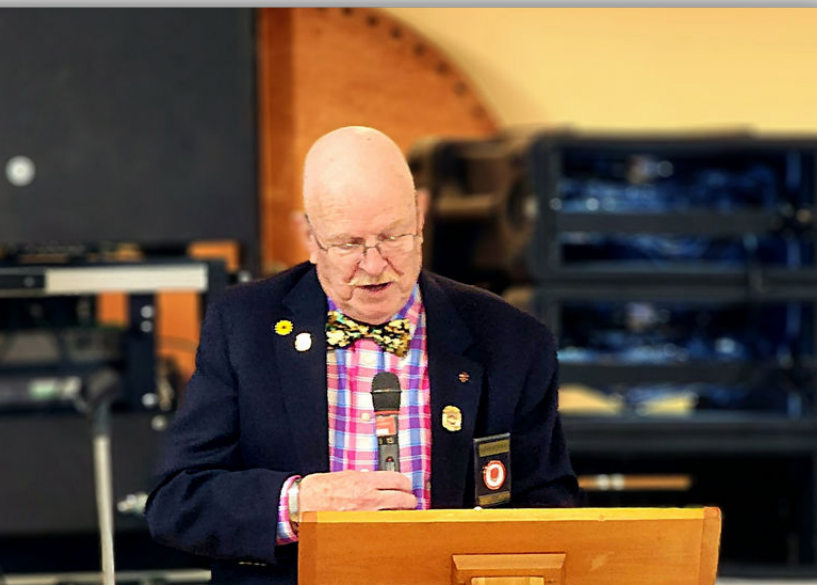

Online Training

National TIM Training Certificate

Through a special agreement with the Federal Highway Administration, the Responder Safety Learning Network (RSLN) offers a National TIM Training Certificate for registered users who complete ten specific RSLN online self-paced programs.

To earn credit for each program, you must view the program in its entirety and pass the Skills Challenge test. Once you earn credit for all ten programs, you will be able to download a special certificate that is the equivalent of completing the National Traffic Incident Management Responder Training Program.

When you have completed all the programs, expand the Dashboard by clicking the small arrow, Then, click National TIM Training Certificate to download your certificate. Once you have earned the certificate, it will be listed in your transcript. If you have any technical problems, please file a support ticket.

Once you complete the National TIM Training Certificate, consider completing the "Roadway Incident Response Safety Leadership Certificate." This certificate builds on the National TIM Training Certificate with knowledge and skills needed for effective on safety in roadway incident responses. You must complete the National TIM Training Certificate on RSLN before you are able to earn this certificate.

Early History Westminster Fire Engine Hose Company No. 1

In 2023, the Westminster Fire Engine & Hose Co. No. 1 is celebrating its 200th anniversary, one of only 5 fire companies in Maryland that can claim this unique distinction. Though the celebration in 2023 marks 200 years since the organization of the Union Fire Company, the history of fire protection in Westminster dates back to at least January 29, 1808, when the Maryland General Assembly passed an act authorizing:

"An ACT authorizing a lottery to raise a sum of money to purchase a fire engine and finish the church in Westminster-town, in Frederick county." The act provided that "..... a lottery for raising a sum of money, not exceeding two thousand dollars, and to sell and dispose of the tickets thereof; provided, that the said James Haffee, Jacob Shriver, Daniel Zacharias, John Fisher, and Jacob Yingling...." would be required to post a bond of \$6,000 with the State of Maryland and recorded in the clerk's office in Frederick. The lottery authorization required that the church be finished, and the fire engine should be purchased within 18 months of the issue of the lottery.

The Westminster Fire Engine Hose Co. No 1 has based its continuous history of recorded fire protection on 1823 when the Union Fire Company was organized in Westminster. When this fire company was organized, Westminster was not an incorporated municipality, and the fire company was actually located in Frederick County.

Westminster was still a relatively small agricultural town. In 1824, an act to prevent Hogs from going at large in the town of Westminster in Frederick county passed at November session, 1797 chap. 47, be, and the same is hereby repealed." This act was most likely in response to the growing community and business district, certainly bothered by large packs of hogs being led down Main Street!

It was not until 1830 that the Town of Westminster, now the City of Westminster, was incorporated with



several surrounding communities included within the municipality:

LAWS OF MARYLAND:1830. CHAP 98.
Passed Feb 14, 1830, state: An Act to incorporate Westminster in Frederick County. Adjoining towns to be called Westminster

Section 1. Be it enacted by the General Assembly of Maryland, That the four adjoining towns now called and known by the names of Westminster, New London, Winter & Addition, and New Edenborough, together with Pigman Addition, and the intermediate space between Winter Addition and Pieman Addition, shall forever hereafter be called and known by the name of Westminster."

Though the history on the website of the Westminster Fire Engine and Hose Co. No. 1 shows a date of 1885 when the town water system was complete, an act of the Maryland General Assembly in 1824 provided for the incorporation of the Westminster Water Company. This initial legislation was followed by an act in 1826 that was..." introduced a supply of wholesome water into the town of Westminster. And whereas, the health and convenience of the inhabitants as well as security of property against the ravages of fire, would be greatly promoted..." This act was passed on February 24, 1826, under the auspices of Commissioners Abraham Wampler, John Fisher, and Jacob Yingling. The act authorized the commissioners to raise-

\$3000 in stock with \$300 shares; thus, the initial stock value was \$10 per share. As noted earlier, when the fire company was organized in Westminster, the town was an unincorporated village in Frederick County. The incorporation of Westminster took in several surrounding villages into the single municipality of Westminster, as noted in the actual act of the Maryland General Assembly:

1830.CHAP 98. Passed Feb 14.

CHAPTER 98. An Act to incorporate Westminster in Frederick County.

Adjoining towns to be called West-minster-

Section 1. Be it enacted by the General Assembly of Maryland, That the four adjoining towns now called and known by the names of Westminster, New London, Winter Addition, and New Edenborough, together with Pig-man Addition, and the intermediate space between Winters Addition and Pieman Addition, shall forever hereafter be called and known by the name of Westminster.

Westminster was still in Frederick County; it was not until 1836 that a "...considerable body of the inhabitants of Baltimore and Frederick Counties..." petitioned the Maryland General Assembly to become a separate county.

The Maryland Archives records the General Assembly passed-- an act dividing parts of Baltimore and Frederick Counties into a new Maryland county, Carroll County:

"CHAPTER 256. An act for the division of Baltimore and Frederick Coun- Passed Mar. 25, 1836 ties, and for erecting a new one by the name of Car rail, and to alter and change the Constitution of this State, so far as may be necessary to effect the same. WHEREAS, a considerable body of the inhabitants of Baltimore and Frederick counties, by their petition to this General Assembly, have prayed that an act may be passed for a division of said counties and for erecting a new one out of parts thereof; and whereas, it appears to this General Assembly, that the erecting of a new county out of such parts of Baltimore and Frederick counties, will conduce greatly to the ease and convenience of the people thereof."

With this action, the Town of Westminster and the fire company organized in Westminster were no

Longer in Frederick County, and Westminster became the county seat of Carroll County.

The formal name of the Westminster Fire Department is Westminster Fire Engine Hose Company No. 1. It was typical for the fire company organized in a community to claim number 1 in case other companies were later collected in the community, such as did happen in Westminster. In fact, according to the history on the Westminster website, another company unsuccessfully attempted to form in Westminster. Other fire companies organized in larger cities such as Frederick and Hagerstown, Maryland, and York, Pennsylvania. They used the progression of numbers added to their name as they managed, such as the Junior Fire Company No. 2 and United Steam Fire Engine Company No 3 in Frederick.

The company numbers were generally adopted into the legal name of the fire company when the fire company was incorporated. However, usually, these numbers have no direct connection with the company numbers assigned for county communications dispatch purposes. For example, the fire service in New Windsor is the New Windsor Fire Engine & Hose Company No. 1, and the fire company in Manchester is officially the Manchester Fire Engine and Hook and Ladder Company No. 1. Another Carroll County fire company is the Hampstead Volunteer Fire Engine & Hose Company No. 1. The Mt. Airy Volunteer Fire Company is Carroll County Company 1 in the communications line up, though not organized until 1926, well after the fire above companies.

The early hose reel of the Westminster Fire Engine, Hose Company No. 1, was featured on a coffee mug issued as part of the series of mugs to raise monies for the Volunteer Firefighters Room at the University of Maryland. MSFA Past President Bernard "Buck" Gladhill was instrumental in coordinating the Volunteer Firefighters Room and organizing the collector series mugs. Ten different numbered mugs were issued annually for ten years. The motto "Prompt In Danger" was included on the mug that featured the beautiful hose reel presently on display at the firehouse museum in Westminster.

Congratulations to Westminster Fire Engine & Hose Company No.1 for two centuries of service.

**Frederick County Fire Museum
to Feature New Exhibits

Two new exhibits will be featured when the Frederick County Fire Rescue Museum opens on April 15, 2023. The newly restored 1876 Silsby Hose Reel of the Junior Fire Company No. 2 in Frederick will be on public display for the first time. Several years ago, the hose reel was found for sale at a local antique shop. When members of the fire company inspected the reel as it was sitting outside of the store, they discovered the words "Silsby Manufacturing Company, Seneca Falls, New York" markings. They realized they had most likely found the original hose reel belonging to the 1876 Silsby steamer of the Junior Fire Company.

A comparison of the newly found antique reel with other Silsby reels found online confirmed that the age and style of the reel met the design of the Silsby hose reel that would be the companion of the steamer. The 1876 Silsby steam pumper was the first steam pumper in the City of Frederick and remained in service until replaced by a LaFrance pumper in 1908.

The reel was in fair condition but needed some restoration and repairs. The hose reel had been painted a pale bluish green with some needed metal work and damaged wheels that needed to be repaired. A piece of masking tape with the name "Gladhill" was attached to the reel indicating the reel was at one time in the collection of the late MSFA President "Buck" Gladhill. Mr. Gladhill was known to have collected many items and apparatus from the fire companies in Frederick.

Under the guidance of Junior Life Member Jim Deater, work was initially done to repair a dry rotted wheel. More work was done to restore the metal designs and add a bell. Signage "Junior Fire Company" is displayed on the top of the ornate metalwork. Finally, the reel received a coat of red paint bringing back the glory days when the reel was responded through the streets of Frederick. The hose reel made its public debut when members of the Junior Fire Co. No. 2 pulled the reel in the Annual Kris Kringle Parade in downtown Frederick. Members of the Independent Hose Co. No. 1 assisted in the rehabilitation and transportation of the Silsby reel.



Another new feature at the museum will be a significant accounting of every line of duty death in the history of the Frederick County fire and rescue service. Grayson "Jeep" Abrecht, Life Member and Treasurer of the Junior Fire Co. No. 2, has cataloged all 28 of the line-of-duty deaths in Frederick County since 1840. He has researched newspapers, company records, and other media to complete a comprehensive archive of information on each fallen Frederick County hero. The comprehensive reference book is available for review at the Wall of Honor in the Frederick County Fire & Rescue Museum.

The Frederick County Fire & Rescue Museum will open for the 2023 season on Saturday, April 15, 2023, and will be open Saturdays and Sundays, except holiday weekends, until the first weekend of October. The museum is at 300B South Seton Avenue in Emmitsburg, MD, just north of the National Fire Academy.

**CHIEF EMERITUS WYLIE DONALDSON
ODENTON VOLUNTEER FIRE COMPANY
CELEBRATES 70 YEARS OF SERVICE**

On September 13, 1952, Wylie L. Donaldson, Jr. joined the Odenton Volunteer Fire Company (OVFC) at 14, following in the footsteps of his father and his grandfather, a Charter Member of OVFC. On September 13, 2022, Wylie celebrated his 70th anniversary of active service with OVFC. He was presented a Governor Citation for Outstanding Services to the Citizens of the State of Maryland. From 1960 until 2021, he continuously served as either an administrative officer or a suppression officer, sometimes serving on both sides at the same time. He was Fire Chief for sixteen years and was bestowed with the honor of Chief Emeritus. As Chief, he was a strong proponent of training and community engagement. He was also our President for nine years. He has served on nearly every company committee and is still a key member of our annual carnival committee.

Wylie has also been a strong supporter of the Anne Arundel County Volunteer Firefighters Association (AACVFA). He was the Association President for the 1998-1999 term and initiated a volunteer cadet program within the Anne Arundel County Public School System. More recently, Wylie helped to lead efforts to greatly enhance the Length of Service Award Program to reward volunteers for their service and provide an incentive to retain active volunteers. For his service to the AACVFA, Wylie was inducted into the AACVFA Hall of Fame in 1998 and was named Individual of the Year in 1994 and 2009.

He was also recognized by the 100 Club of Anne Arundel County as an Unsung Hero in 2007.

Wylie has also actively served the Maryland State Firemen's Association (MSFA) for several decades. He has served on numerous committees, most notably as Anne Arundel County's representative on the Executive Committee from 1998 until 2012 and as Executive Committee Chairman from 2011-2012. Wylie presently serves as Chair of the Convention Exhibits Committee. He is also one of the Assistant Treasurers. He is among a few people across the state to win the three most prestigious MSFA awards: The Gladhill-Thompson Award, the Marbery F. Gates Award, and the Robert H. Shimer Administrative Person of the Year Award. Wylie has been inducted into the MSFA Hall of Fame and the Maryland Fire Chiefs Association Hall of Fame. He has also received the Lifetime Achievement Award from the National Volunteer Fire Council and the Maryland Governor's Lifetime Achievement Award for volunteer service.

In summary, Wylie Donaldson has made outstanding contributions to the Odenton Volunteer Fire Company and the fire service in Anne Arundel County and across the State of Maryland for over 70 years. He is a dedicated and highly effective leader and an outstanding role model for the fire service.





Do I Need a Fire Investigator?

Many times the unit or incident commander automatically calls for a fire investigator to check that box off of the incident command tactical sheet. Unit or incident commanders should not feel intimidated or overwhelmed by determining the origin and cause of a fire incident. All it takes is a clear and concise look at the scene and to speak to the homeowner or witness to see if the two match up and that what you are seeing and hearing makes sense.

Recently OSFM investigators have been called to trash fires, vegetation fires and other smaller incidents where the unit officer could have made the call regarding the origin and cause of these fires. Even larger incidents where a recent storm has passed through the area involving lightning and the fire in the house is located within the attic space of the structure. It just takes a little amount of time to piece the picture together.

The OSFM is now sending two fire investigators to all residential and commercial building fires. The fire investigator if needed should be requested once you are on scene and can verify what was on fire and that you are unable to determine the origin and cause of the incident or an injury or death has occurred. I have instructed our investigators not to initiate any contact with the incident commander as to not interrupt the commanders overall control of the incident scene. If you need to speak with an investigator I ask that you initiate that call.

As part of your officer certification as noted in NFPA 1021, Fire Officer Professional Qualifications, Fire Officer II, Section 5.5. you as the unit or incident commander are required to determine the origin

and cause of the fire. Getting back to the smaller fire incidents if there is no evidence of a set fire, no witnesses and the fire has not caused any damage to a structure or injured an individual there is no need to have a fire investigator respond to that scene. A simple notification to the on call investigator is needed for these incidents.



Clearly if there is any doubt please reach out and contact the on call fire investigator and speak about what is there and what you are seeing on the scene. If an investigator is needed, please make sure that every step is being made to preserve that fire scene. Preserving the fire scene is a critical first step in our investigation and should be a priority for the incident commander and personnel on the scene knowing an investigator is on their way.

OSFM personnel are more than willing to attend company, association meetings and training to provide education and information in helping company and command officers on origin and cause determination, requests for assistance and scene preservation. Included with this article is a flow chart to help company officers and commanders when a fire investigator should be requested. Please make copies of this and place in your command vehicles and front line apparatus. Please reach out to your regional OSFM commander with any questions.



On January 13, 2023, **Robert L. "Bob" Rose** received **The National Board on Fire Service Professional Qualifications Pro Board Johnny G. Wilson Memorial Award**. This award is presented annually to an individual who has demonstrated professionalism in the field of fire service certification in the same manner that Mr. Wilson performed for the Georgia Fire Fighter Standards and Training Council.

Bob began his fire service life as a volunteer with the Odenton Volunteer Fire Company in March of 1973 and remains active to this day, approaching 50 years of continuous active service. He is particularly known for mentoring pump operators and his insistence on doing things "the right way."

Bob had a distinguished 30-year career with the Anne Arundel County Fire Department, retiring as a captain. Much of his career was spent in the Training Academy, where he ensured that the training requirements for both volunteer and career personnel were met. During the two years between 1998 and 1990, Lieutenant Rose coordinated the Department's successful efforts to phase in required certifications for all career and volunteer personnel commensurate with their rank. The Department's fully integrated command structure, including required certification for volunteer and career personnel, remains a model.

Bob has been an Alternate Representative to the Maryland Fire Service Personnel Qualification Board (MFSPQB) from 1990 to 1995 and from 2002 to the present, representing



Anne Arundel County, and has attended every annual meeting of the MFSPQB since 2005. He has been a delegation member representing the MFSPQB at every annual National "Pro Board" Conference since 2005. In June 2015, Bob was awarded the Maryland State Firemen's Association Russell J. Strickland Award by the MFSPQB for "...exemplary efforts in the promotion of certification for fire and emergency services personnel in the State of Maryland". In further recognition of his service and commitment, during the 2022 annual meeting of the MFSPQB, Bob was appointed Executive Secretary by acclamation.

Bob has made immeasurable contributions to his volunteer fire company, his career department, the Maryland Fire and Rescue Institute, and to fire service training and certification across Maryland.

The Chaplain's Role In a Fire Department

Many proactive fire departments are implementing holistic support initiatives and health and wellness programs. These programs are designed to educate, promote and encourage the health and well-being of firefighters, which, in turn, directly and indirectly, impacts his or her home and family life. The goal of an effective health and wellness program is to build firefighters' resiliency, improve health outcomes, and enhance their overall quality of life.

Departments are creating a customized health and wellness program based on the National Fallen Firefighters Life Safety Initiatives. One of the key strategic building blocks of the program, Initiative 13, Firefighters and their families must have access to counseling and psychological support in supporting the overall health and well-being of each firefighter (body, mind, and spirit). A chaplaincy program supports the health and wellness of firefighters and their families by reducing the insular paramilitary structure of the department to accommodate and support the human aspects of the fire service through spiritual and emotional care.

There are a variety of health and wellness program models. However, each of these models targets and aims to support three specific elements of the person:

Body: involving one's physical needs, health, and nutrition. **Mind:** involving one's social, emotional, and mental health. **Spirit:** involving the human spirit (as opposed to our physical bodies). A healthy spirit integrates and affects all three elements. A healthy spirit helps us to maintain our health and cope with illnesses, traumas, losses, and other life transitions.

The spiritual component of health and wellness is where we encounter our faith and belief systems. All of us have a faith or belief in someone or something. This faith is what gives us intrinsic value and meaning and

can be defined as having complete trust or confidence in someone or something, such as God, humanity, or nature. Faith is a crucial part of spiritual health and is also the core of hope. Hope is the expectation of a positive, desirable future that gives us all the motivation to continue living.

The chaplain's role: The chaplain's role is to provide a supportive, caring, and compassionate service of spiritual care as a component of a holistic health and wellness program. The chaplain is committed to supporting firefighters and their families in order to help them experience and maintain spiritual wellness and wholeness.

The chaplain's principal goal is to simply be a "presence," offering support by meeting people where they are and offering encouragement, compassion, and care during whatever life challenge or situation they are in. The chaplain serves those who serve with spiritual support. Chaplaincy is not about making people feel good or being a nice person, a helpful person, or even a good person. Chaplaincy is about being a strong spiritual "presence" in difficult circumstances and situations.

Duties of the fire chaplain

Some of the duties a fire chaplain may perform include the following:

- Conducting and/or assisting with fire department funerals or memorial services.
- Caring for injured or sick personnel and families and doing hospital visits.
- Involvement with Critical Incident Stress Management/Peer Support Teams/training.
- Offering support and assistance at emergency incidents.
- Acting as a liaison with local clergy, churches, or faith groups.
- Facilitating invocations/prayers at ceremonies and special events.
- Educating fire service personnel and families in areas of spiritual and emotional wellness.
- Acting as a confidential listening ear to personnel and family members.
- Recommending resources for personnel and family members who are seeking assistance for counseling or other wellness initiatives.
