Best Thanksgiving Wishes from all of us at the MSFA Volunteer Trumpet. Don't burn the turkey this holiday, and follow these safety tips!

Top safety tips around the Thanksgiving Holiday from NFPA

- Stay in the kitchen when you are cooking on the stovetop so you can keep an eye on the food.
- Stay in the home when cooking your turkey, and check on it frequently.
- Keep children away from the stove. The stove will be hot, and kids should stay three feet away.
- Make sure kids stay away from hot food and liquids. The steam or splash from vegetables, gravy, or coffee could cause serious burns.
- Keep knives out of the reach of children.
- Be sure electric cords from an electric knife, coffee maker, plate warmer, or mixer are not dangling off the counter within easy reach of a child.
- Keep matches and utility lighters out of the reach of children – up high in a locked cabinet.
- Never leave children alone in a room with a lit candle.
- Keep the floor clear so you don't trip over kids, toys, pocketbooks, or bags.
- Make sure your smoke alarms are working. Test them by pushing the test button.

K9 Kachina Retires From the Office of the State Fire Marshal

With a list of accomplishments as long as her leash, beloved K9 heads into retirement.

STATEWIDE (September 29, 2023) - After eight years with the Office of the State Fire Marshal, Kachina, one of Maryland's most beloved arson detection dogs, is retiring.

The ten-year-old black lab is one of four Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) trained dogs within the agency. She was the most senior canine among the 62 teams across the United States. She and her partner, Master Deputy State Fire Marshal Oliver Alkire, have assisted in over 600 cases in their time together throughout Maryland, Delaware, and Pennsylvania.

During her career, Kachina has responded to or trained in every Maryland county and Baltimore City, an accomplishment that few K9s have experienced and a testament to her drive and dedication to everyone in Maryland.

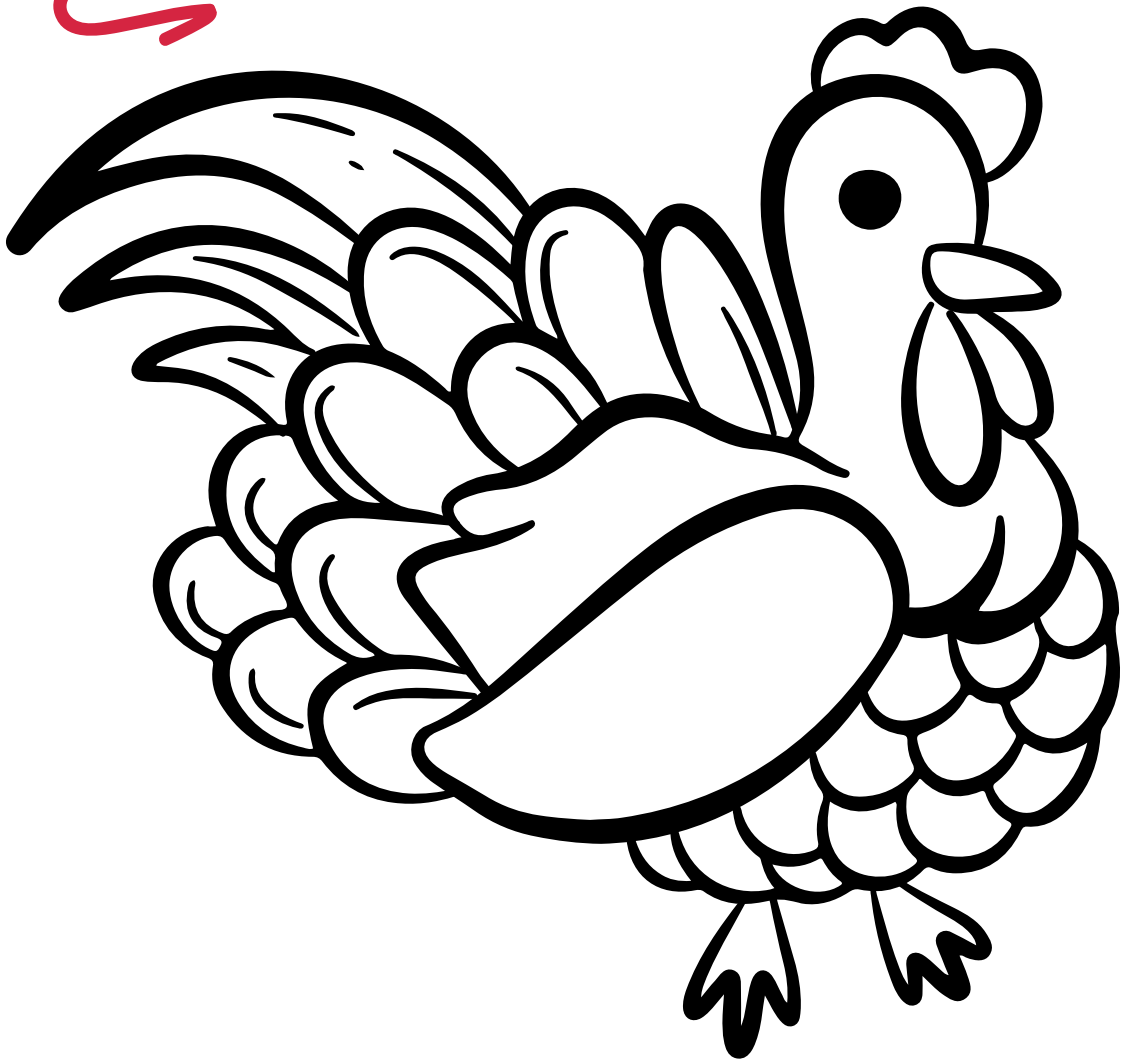

The Colburn Cup – An Award of Distinction

The Colburn Cup was created in 1932 and named for Past President Dr. George W. Colburn. Dr. Colburn served as President of the MSFA 1931-1932 and Chairman of the Executive Committee 1930-1931. At the 40th annual convention of the MSFA held in Frostburg in June of 1932, the Colburn Silver Cup was presented to the MSFA by retiring President Colburn. The award was to be presented in line of succession from year to year to a firefighter within the MSFA member companies for an outstanding act of heroism or for some outstanding act for the good of the association. The qualifications and awards are to be made by the Board of Trustees who shall act as judges. This cup is to be presented at the annual convention and conference of the MSFA with appropriate ceremony.

The Princess Anne Volunteer Fire Company, home company of Past President Colburn, houses the original Colburn Silver Cup since its retirement in 1958. They now provide the Colburn Cup each year which the recipient keeps.

The rules and qualifications for the Colburn Cup are maintained on the MSFA website, www.msfa.org on the awards pages. The cup is only awarded to a single individual for heroism or a very outstanding act for the good of the MSFA. Many submissions for this award contain a group of persons that attained a successful incident mitigation, and later are then submitted for this award. Unfortunately, the award is for an individual only. In past years the award was occasionally given to more than one person who participated in an incident. This was an incorrect application of the award, and after discussion several years ago with the sponsoring company it was determined that only one individual would receive the award moving forward.

There have been years where there were no qualifying applications for the award and the Colburn Cup was not presented. We hope that member companies of the MSFA will remember to submit a member that showed individual heroism in saving lives or injury during the year between conventions. An application can be submitted at any time during the year between conventions to the Trustees Secretary. Any questions can be directed to any of the Trustees.

“Mr. Buck”
Volunteer Trumpet
Chip’s Firehouse Logbook
October, 2023

Recently, the Frederick County Fire & Rescue Museum was in need of a piece of Frederick County fire apparatus to be displayed as the 1939 Ahrens-Fox of the United Steam Engine Company No. 3 of Frederick was removed from the museum for repairs. I was aware that Mr. Bernard “Buck” Gladhill purchased the United 1919 Ahrens-Fox many years ago, and that engine was still stored at the Gladhill Tractor Company in Jefferson. I called the son, Mr. Maurice Gladhill, to see if he would be willing to have the antique engine on public display. As noted in the last Trumpet, he did agree, and the 1919 Ahrens-Fox lettered Gladhill No. 1 was on display the remaining weekends of the museum season.

“Mr. Buck” was an icon in Damascus and dedicated to the Maryland State Firemen’s Association and the volunteer fire service of Maryland. He was a charter member of the Damascus Fire Volunteer Fire Department and remained active in the fire department until his death at age 96 in 2016. I recall meeting Mr. Buck at a Maryland State Firemen’s Association Convention in the early 1970s when he fostered a project to develop the Maryland Volunteer Firefighter’s Room at the Adult Education Center of the University of Maryland.

“Mr. Buck” helped design and develop the room with artifacts from the MSFA, including some plaques and awards, as well as a beautiful diorama highlighting three centuries of volunteer firefighting in Maryland. To help fund the Volunteer Firefighter’s Room, “Mr. Buck” sold special numbered coffee mugs in a series over a 10-year period. Each mug had a piece of Maryland apparatus, with the “Lily of the Swamp,” the famous Clapp and Jones steam pumper of the United Steam Fire Company No. 3, having the honor of being on the first issued mug.

The Lily of the Swamp is also the featured model in the diorama to highlight firefighting in the 1800’s. A model of the 1878 steamer, a 1700’s period hand pumper, and models of the 1970 Mack CF pumper and Aerialscope are also a part of the three-century diorama. The Mack models were donated by Mack Truck, Fire Apparatus

Division, who were also on hand for the dedication of the Volunteer Firefighter’s Room. “Mr. Buck” was extremely proud of his involvement in making this room a reality at the University of Maryland.

Unfortunately, much of the room was almost lost when the Adult Education Center was contracted out, and major renovations forced the removal of the diorama and a beautiful set of Maryland Oak display cases. Thanks to the diligence of Past President Frank Underwood, then serving as Deputy Chief for volunteers in the Prince George’s County Fire and Emergency Services, most of the hard work of “Mr. Buck” was saved and continues to be on display at the Frederick County Fire and Rescue Museum in Emmitsburg. PP Underwood continues to serve as the Chairman of the MSFA Historical and Archives Committee and keeps a watchful eye on the remaining artifacts in College Park.

“Mr. Buck” was an avid collector of fire apparatus and memorabilia, purchasing items from around Maryland, in particular several items from Frederick. He had over 20 pieces of apparatus in a storage barn in Damascus. His collection included the 1949 Ahrens-Fox of the Junior Fire Company No. 2 in Frederick and the 1919 Ahrens-Fox formerly owned by the United Steam Engine Company No. 3. The 1919 “Fox” was his prized possession. As a chain-driven, right-hand drive apparatus, “Mr. Buck” had the engine painted and the letter “Gladhill No. 1”. He saved the engine from the scrapyard by \$1. His son, Maurice Gladhill, tells the story that a local scrap dealer bid \$500 to purchase the 1934 Ahrens-Fox of the Junior Fire Company and



\$500 for the 1919 Ahrens-Fox from the United. "Mr. Buck" saved the 1919 "Fox" by bidding \$501, thus keeping the beautiful 1919 Ahrens-Fox for generations to see. A picture of both "Foxes" in storage at the Walkersville Volunteer Fire Company prior to the sale is on display at the Frederick County Fire Rescue Museum in Emmitsburg.

Other Frederick artifacts on display at the museum from Frederick that came from "Mr. Buck's" collection include the life net that was carried on Ladder 4, the 1952 American LaFrance tractor-drawn ladder truck of the Citizens Truck Company. Most likely was the owner of what is believed to be the 1876 Silsby Hose Reel of the Junior Fire Company No 2 in Frederick. During my tenure at Frederick County Emergency Communications, I drove by an antique dealer at that time located in front of the Gladhill Tractor Mart on East Patrick Street in Frederick and noticed a hose reel sitting outside in a grass area.

I stopped by to check out the reel and discovered the words "Silsby Manufacturing Company, Seneca Falls, New York." Literally shocked to see these words, I asked the antique dealer how much he wanted for "that old hose reel." When he responded with \$1000, I immediately went back to my office located less than a mile away and began to research the internet to determine the probably age of the hose reel. It became evident the rig was most likely the original hose reel of the Junior Fire Co. No. 2.

A piece of masking tape with the name "Gladhill" indicated this piece of fire service history probably came from the collection of Bernard "Buck" Gladhill, giving an even higher probability it came from Frederick. The Junior Fire Company No. 2 purchased the reel assuming it was originally a part of the compliment of the 1876 Silsby steamer. Under the direction of Junior member Jim Deater, the reel was rehabbed and is now also on display at the Frederick County Fire & Rescue Museum.

"Mr. Buck" also collected bells, literally hundreds of bells. Fire bells, church bells, railroad bells, steamship bells, and any other kind of bell you could think of. He donated a large antique bell, which was placed in a

Column at the entrance to the National Fallen Firefighters Memorial in Emmitsburg. According to his lifelong friend, the late MSFA Past President Leonard King, who served on the Board of Directors of the National Fallen Firefighters Foundation, the bell had to be totally dismantled to be transported from the storage barn in Damascus to Emmitsburg where it proudly honors our nation's heroes.

In the 1970's, the conversation started within Frederick County for the need for a county fire and rescue training center. The late Bob Renner, a Montgomery County firefighter and chief of the New Midway Volunteer Fire Company who was active in the MSFA, headed the efforts to convince our county commissioners to back the project. Chief Renner headed a search committee for property and dealt directly with "Mr. Buck" and the Gladhill family.

During an interview prior to his death, Mr. Gladhill said: We were looking to the future. We thought it was a good investment for everyone. ... Without training, you have no business being a fireman; His family donated part of the property where the Frederick County Public Safety Training Facility now stands on Reich's Ford Road near Frederick.

In an article I wrote in the Trumpet a few issues ago, I made a glaring error when I stated that "Mr. Buck" has served as the president of MSFA. As he was such a major center of influence when I first became active, I just always had in my mind he was a past president years before I became active. I learned a valuable lesson when I was told otherwise and double-checked the list of MSFA presidents.

Though most recently we have his son, Maurice Gladhill, to thank for allowing "Gladhill No. 1" to be publicly displayed, we have "Mr. Buck" to thank not only for saving the engine from the junkyard, but for the many actions he took to help preserve the history and traditions of the fire service in Maryland, particularly in Frederick and Montgomery County.

Though he didn't quite make it to his goal of living to 100 years of age, he will live on in spirit through his family and his dedication to MSFA.

Who Are the Maryland State Firemen's Association Trustees?

This is a question we hear far too often. The MSFA Trustees are five persons elected from the member companies of the MSFA, who are there to administer the Line of Duty injury and death benefits to member company personnel that are injured in the line of duty or death benefits to the surviving family of member company personnel that die in the line of duty. The members of the Trustees are elected for a five-year term, thus, one Trustee is elected each year at the annual convention. The funds for the Trustee Benefits come from the State of Maryland budget each year and are earmarked for the specific purpose of assisting fire service personnel injured in the line of duty or assisting the families of personnel killed in the line of duty. The definition of "line of duty" injury or death is defined in the Annotated Code of Maryland Article 7-202 through 7-204, and each application for assistance must adhere to this definition.

The MSFA Trustees meet as needed and at each Executive Committee meeting or before and review any applications that have been submitted for benefits. The forms are checked for complete and accurate information. The content is checked for applicability and qualification. Benefits for line-of-duty injuries can be short-term or long-term. Death benefits are not only for surviving spouses but dependent children as well. There is also a benefit for the college education of surviving dependent children. All types of applications must be considered and approved for each claim.

Currently, Doug Alexander from Mount Airy is the Chairman of the MSFA Trustees. The Vice Chairman is Jeff Clements from Potomac Heights, Tommy Mattingly from Leonardtown is the Secretary/Treasurer, and Theresa Collins from West Friendship and T. R. "Robbie" Blackiston from Sudlersville fill out the Board of Trustees. The Trustees are available to assist a member company to apply for benefits at any time. If anyone should have a question on whether someone is eligible for benefits from the Trustees or needs assistance with an application, please contact one of the Trustees for assistance. All requirements and forms needed to file a claim are on the www.msfa.org website on the Trustees page.
