

## Mental Health Awareness Month

According to the National Institute of Mental Health:

"Learning what causes or triggers your stress and what coping techniques work for you can help reduce your anxiety and improve your daily life. It may take trial and error to discover what works best for you. Here are some activities you can try when you start to feel overwhelmed:

- Keep a journal.
- Download an app that provides relaxation exercises (such as deep breathing or visualization) or tips for practicing mindfulness, which is a psychological process of actively paying attention to the present moment.
- Exercise, and make sure you are eating healthy, regular meals.
- · Stick to a sleep routine, and make sure you are getting enough sleep.
- Avoid drinking excess caffeine, such as soft drinks or coffee.
- Identify and challenge your negative and unhelpful thoughts.
- · Reach out to your friends or family members who help you cope in a positive way."

Call or text 988 to connect with the 988 Suicide & Crisis Lifeline. The Lifeline provides 24-hour, confidential support to anyone in suicidal crisis or emotional distress.


## Dear Volunteer Trumpet Safety Advocates and Readers,

In Memory of Charles Barnhart, Jr.

Deacon Charles E. "Charley" Barnhart, Jr., 69, of Taneytown, passed away on Monday, April 8, 2024, at Carroll Hospital after a battle with cancer. Born December 5, 1954 in Gettysburg, PA, he was the son of the late Martha (Jeffcoat) Barnhart and Charles E. Barnhart, Sr.

Charley graduated from Francis Scott Key High School in 1972 where he was active in the choral music department, singing all four years and participating in musicals.

Family life for Charley was not a bed of roses. He believed the church would never have influenced his life had it not been for Mary and Kent Hall. They took him into their home and taught him that as God's child he was someone who mattered. They challenged Charley to live life to the fullest and to live it by being a part of God's kingdom and participating in the church. The Messiah United Methodist Church in Taneytown gave Charley a strong foundation of God's love to build his life on.

Helping people gave Charley a great deal of satisfaction. He had a long history of serving within the fire community beginning with the Taneytown Fire Co. in 1973, where he was Recording Secretary, Chaplain, and Ambulance Captain over the years. During this time he was also employed as a Dispatcher at the Carroll County 9-1-1 Emergency Center and in 1983 became the first paid engineer at Reese Vol. Fire Co. Charley also became the first EMS Training Coordinator for the county. He was elected President of the Carroll County Vol. Fireman's Association in 1989 and was made an Honorary Life Member of the Union Bridge Fire Co. In 1998, he became a life member of the Taneytown Fire Co. He served as Chaplain for the Cumberland Valley Fireman's Association and the Maryland State Firemen's Association. He was a school bus driver and eventually owned and operated Barnhart's Bus Service serving Carroll County Public Schools. More recently, he worked for some of the local funeral homes.

In addition to fire service, Charley was very involved in the work of the Lord. He served as Choral Director from 1987-1998 at Trinity Lutheran Church in Taneytown. He also served as Deacon at Trinity until he left to become Deacon at Keysville Lutheran Church up until his death. He has officiated many weddings and funerals throughout the community and will be missed by many.

He is survived by foster mother Mary G. Hall, foster siblings Lura Kappes, Matthew Hall (Meagan), and Allison Lindahl (Doug), long-time friend A.J. Makibbin, 5 nieces and 1 nephew. He was predeceased by his parents, brothers Ronald and Michael, and foster brother-in-law Mickey Kappes.

#### COMMENT PERIOD EXTENDED FOR OSHA'S UPDATED EMERGENCY RESPONSE STANDARD

"On February 5, the Occupational Safety and Health Administration (OSHA) published a Notice of Proposed Rulemaking (NPRM) to modernize the agency's "Fire Brigades" standard with a proposed new "Emergency Response Standard." This NPRM's publication triggered the beginning of a public comment period that was initially scheduled to conclude on May 6. Thanks to feedback from the emergency services community, OSHA has extended this public comment period to June 21, 2024.

The proposed updated standard would issue several new requirements that would be very burdensome, and in many cases impossible, for volunteer fire departments to comply with. Specifically, there would be prohibitively restrictive standards on physical exams, the purchase of new equipment, and the formation of emergency plans that exceed the staffing capabilities of many volunteer departments." ~ National Volunteer Fire Council

Here we go again. The 2024 MSFA Convention and Conference will once again have an amendment on the annual election ballot to change the name of the Maryland State Firemen's Association to the Maryland State Firefighters Association.

At the December 3, 2023, meeting of the Executive Committee of the Maryland State Firemen's Association in Westminster, the representatives of the MSFA Executive Committee overwhelmingly voted, 12 in favor and 1 opposed, to submit an amendment to the Constitution and By-Laws of the Maryland State Firemen's Association to change the official corporate name to the "Maryland State Firefighters Association".

In accordance with the Constitution of the Maryland State Firemen's Association, ARTICLE VII – AMENDMENTS, "... proposed amendment or revision shall have been submitted, in writing, by the Executive Committee or a member company..." Thus, as stated in the Constitution, the Executive Committee has the authority to submit changes and amendments to the Constitution. To highlight the importance of the issue of changing the name to a genderneutral nomenclature, the Executive Committee has voted to submit a specific name change to the membership for a vote at the 2024 MSFA Convention.

The issue of changing the name of our great association has been a point of discussion for over 10 years. This is the fourth article I have written regarding the need to change the name. Over 30 state fire service organizations nationwide and most of the county associations in Maryland have already adopted a gender-neutral name. Most

recently, the Cumberland Valley Firemen's Association has passed a resolution to change the name to Cumberland Valley Firefighter's Association without controversy. The issue of changing the name of the MSFA has been a millstone around the neck of our association for several years. Though we have had political pressure to make the change, the real pressure is coming from the change in society.

The Executive Committee has taken the leadership role on this issue by being the entity that submits the amendment change. Hopefully, this will be the only amendment submitted. Last year, the amendment for "Firefighters" received a majority of votes but did not receive the necessary 66 2/3 required to pass.

We continue to receive negative media coverage in newspapers and even on local television, critical of the MSFA for failing to change our name. After the last convention, headlines such as "Maryland State Firemen's Association Fails to Change Name" or "Maryland Firemen Refuse to Change Name" were prevalent in newspapers, online posts, and television news stories. We are missing out on positive media coverage for our association by having to constantly respond, comment, and try to defend why we fail to bring our name into the 21st century.

We are a political organization. In 1893, the Legislative Committee was one of the two original committees that had been implemented when MSFA was organized. We need to accept that political issues are part of doing business. With an extremely liberal legislature with a substantial number female legislators, this issue will not simply go away. The more we delay, the more potential negative media coverage, public reaction, and possible negative action within the state and even federal government. I am very concerned that, at some point, there could even be possible questioning at the federal grant level if this issue continues to expand.

Our public image is getting tarnished with each negative vote. As we launch aggressive recruitment of young members of our communities to join the fire & rescue service, we must project the image of an organization poised for the future. How can we recruit young females into the fire and rescue service when our names do not provide an open invitation? Not all females are offended by our present name. But, in today's society, with a more openminded and more demographically diverse service, our name must reflect our intent that this is an organization NOT comprised of males, but an organization that has developed into the leading state fire and rescue organization in the nation that is diverse and welcoming to all. Our new name will demonstrate this intent.

Nobody likes the excessive pressures from outside sources that we have had to endure in the last few years. I fully realize there are individuals and local associations that are adamantly against any change. I am also very aware that many individuals, yours truly included, were very much in favor of an "all service" approach to the name change with "Rescue" or "EMS" included in our name. However, we all must be willing to meet the middle ground with a compromise that will affect the needed changes to meet today's societal expectations and help retain much of the integrity of the tradition, history, and identity of the MSFA. Our logo will remain the same, and the acronym MSFA will remain the same.

This change would be the least costly change as we

annually make numerous business changes with the change of presidents. Thus, the name change would occur in coordination with the change of president.

I am hopeful that 66 2/3 of the member companies understand the importance of this critical issue and will support the amendment submitted by the Executive Committee and vote in favor of "The Maryland State Firefighters Association" in June of 2024.

#### Comments on Proposed OSHA Regulations on Fire Service Health and Safety By: Chief Clarence "Chip" Jewell, Chairman MSFA Executive Committee

NFPA standards have long been the gold standard for the nation's fire and rescue service. Over the years, this standard-making body has extended into developing consensus standards for every facet of the fire and EMS service. Firefighter training standards, medical/physical standards, apparatus standards, and numerous operational standards are viewed as the industry standards our fire and rescue departments strive to achieve.

Standards are not legal and binding but can be used during civil litigation as the industry standard that should utilized. Though failing to follow the standard does not result in criminal actions, a court could hold an emergency service negligent for failing to comply with the established and accepted standards. To adopt NFPA standards into federal regulation would effectively place many fire and rescue department in non-compliance that could have a disastrous effect, particularly on the nation's volunteer fire and rescue service.

Even major fire and rescue organizations that are fully career or combination departments would be faced with unfunded legal mandates that will pose a tremendous fiscal burden on fire departments, municipalities, and county governments. I fully support and endorse every effort to enhance the health of our personnel. However, many, many departments simply cannot afford the financial burden. The implementation of NFPA 1582, NFPA 1500, and aggressive programs such as the 16 Life Safety Initiatives have dramatically reduced operational line-of-duty deaths over the last 40 years.

Unfortunately, every fire department does not have the manpower or financial resources to fully implement NFPA 1582 and most likely would never be able comply with mandatory regulations. Many volunteer fire and EMS departments struggle each day to meet daily expenses to keep the doors open and apparatus running. Some volunteer fire departments have an operating budget of less than \$10,000 a year. Carnivals, chicken dinners, and bingo are held just to raise funds to pay monthly bills. Even larger suburban and metropolitan fire and emergency service organizations struggle to recruit personnel and convince political leaders to provide funding.

One size does not fit all. The volunteer fire and rescue service of our nation is as varied as the nation's climate, from the very large urban volunteer and combination fire departments with over a hundred members to the oneengine rural departments lucky to have three people responding to an incident. Our country's thousands of emergency service organizations stand as centurions protecting villages, cities and counties throughout our nation. A fire company that has limited funds will be forced to choose to pay the insurance bill or provide annual physicals to members. As many volunteer fire departments depend on older members, medical physicals could easily cost \$2,000 per person.

Even more of a concern would be the proposed requirement to ensure members are fit for duty. Preemployment or member testing and fit-for-duty evaluations would not only be time-consuming but also a determent to potential new and incumbent members. The record-keeping and human resource requirements would essentially create a need for a full-time human resources person in every department. Our nation is suffering from a decrease in volunteer participation in fire and EMS. Many volunteer companies are struggling to recruit and retain volunteers, and adding more time and bureaucracy to what is often an already somewhat burdensome process will pose another barrier to keeping members on the rolls or convincing the public to join their local fire department. Though most companies do provide some basic form of evaluation for fitness for new operations, to mandate a specific regiment as outlined by NFPA 1583 would be time-consuming and burdensome, ultimately defeating the purpose.

Training requirements, particularly those to assure members are trained to the most recent standards, would be cost-prohibitive and extremely time-consuming for the volunteer service. Can you even imagine how many NFPS standards are frequently changed and the time and effort it takes to ensure every member meets any updates annually? In many states, the individual firefighter or the volunteer fire company must pay for training from a college or other training service or agency.

Other proposed regulations based on NFPA standards could ultimately create voids in emergency services in many communities. The 10-year gear requirement is well-intentioned. In many situations, the turnout gear rarely sees interior firefighting. Many small departments do not have the financial ability to replace gear every ten years. And though the Fire Act Grant is presently available for such purchases, these funds are limited and a constant target of budget hawks in Congress. The present standard for two sets of gear is cost prohibitive, even for many large career departments. Adopting these standards into regulation will again be unachievable for many departments. Even larger departments simply do not have

the funding available to meet these well-intentioned but very costly standards.

Presently, OSHA conducts operations with a more positive attitude, working with organizations to meet compliance rather than the more government-hard hammer of the past. Even so, many fire and rescue companies will never be able to comply with NFPA standards that are proposed to become regulations. No one can predict the actions of OSHA or field representatives of OSHA that could use a more aggressive stance against fire and rescue companies that are non-compliant and potentially forcing many departments out of business, thus jeopardizing public safety.

The Maryland State Firemen's Association is very much involved in this issue on many levels. President Smothers, Executive Director Loveless, Past President Cox, and Executive Committee Chair Jewell are all providing input on a committee organized by the Maryland Occupational Health and Safety Administration. Past President Dave Lewis is a Maryland director with the National Volunteer Fire Council and is involved in the issue on many fronts. Executive Committee Chair Jewell is a member of the Small Business Administrative Administration OSHA Emergency Response SBREFA Panel. MSFA is active on many fronts. We are NOT opposed to initiatives that enhance the health and safety of our personnel. The NFPA standards are the best practices that our volunteer fire and rescue service strive to achieve. We are very

fire and rescue service strives to achieve. We are very concerned that making these standards a legal and binding regulation puts many volunteer companies in jeopardy of being immediately in violation of a law, thus subject to citations and fines.

The efforts of fire and rescue companies of our nation in the last two decades to address health and safety are evident when reviewing the past history of line-of-duty deaths. Our service has continued to see a decrease in operational line-of-duty deaths in the last 40 years due to the continued work by departments to implement NFPA standards as practical. Efforts to decrease exposure to cancer and increase medical evaluations are ongoing. Though I am very supportive of efforts to achieve every NFPA standard, utilizing these standards as OSHA regulations will not have the desired effect but rather pose an unnecessary and often unachievable legal regulation that could create an increased void of volunteers and service delivery to communities across our county.

The Frederick County Fire & Rescue Museum, located at 300B South Seton Avenue in Emmitsburg, has opened for the summer season with several new exhibits. The 1919 Ahrens-Fox pumper on loan from the Gladhill family and formerly owned by the United Fire Company in Frederick will continue to be displayed until the United 1939 Ahrens-Fox is returned from repairs.

The Junior Fire Co. No. 2 of Frederick has loaned a recreated uniform of a "Junior Defender," one of the fire company militia units in Frederick that responded to John Brown's raid of Harper's Ferry. An 1850's tin type of Junior Defender wearing the actual uniform is also on display. Additionally, the Junior's 1876 Silsby hose reel has been restored and is on display. Pictures from the collection of the late John Hoglund have been loaned to the museum and provide some interesting reflections on the MSFA. The museum has many items relating to the history of the MSFA.

#### **Heatstroke to Children Left in Cars**

#### Outdoor Stand-Up Temperature Display

#### Available for Use for Maryland Community Events

On average each year, 38 children die from heatstroke when left alone in cars. In 2023, **29** children died this way. Awareness and behavior modification among caregivers are key to preventing the majority of these tragic deaths. The Outdoor Stand-Up Temperature Display is an excellent tool to create awareness of how a vehicle can quickly heat up in the sun to where the inside

temperatures would kill a child. This display features:

- A tall metal (78") or tripod free-standing display with two LCD temperature monitors attached at the top: one for the in-vehicle temperature and one for outside/ambient temperature.
- Cable connectors with thermometers to place in and outside the car.
- Large magnet-signs to place on display car to convey message.
- Safe Kids display sign for the middle of the frame.
- 100 foot extension cord.

#### **Guidelines for Use**

- Arrange for pick up and return of the large and heavy display in its storage case.
- · Return the display within four business days to the pre-arranged location.
- Arrange for an outdoor location for this: a parked vehicle is needed within 10 feet of the temperature display.
- Access to electricity is needed; a 100 foot extension cord is included with display.
- Do not expose the display to rain.
- Allow at least 30 minutes for set up time, with at least two strong people helping.
- Follow the directions for assembly carefully. Call 410-706-8647 if there are questions or concerns, or after hours, call Susanne Ogaitis at 410-491-7803.
- Ensure that someone will be near the display at all times.
- Properly pack and transport the display in its original case.
- Clean the display if needed with a soft, damp cloth.
- If any damages occur, you will be responsible for repairs or replacement.

#### **Additional Activities to Accompany Display**

- Place a doll or stuffed animal that doesn't look real strapped into a car seat inside the hot car. Use a car without dark windows to allow the car seat to be seen.
- Ask local car dealers to loan the vehicle, as a public service.
- Have supplemental materials available: handouts, posters to give away, or incentive items with campaign messages.
- Invite local media to cover the campaign and film the temperature changes.
- Cover the campaign on social media, with frequent updates of temperature changes and what that would mean to a child occupant of the car.
- Simultaneously conduct an inside display on the same subject by borrowing one
  of the 6' tall stand up posters ("Cars can overheat rapidly..." or "Take action...").
